In terms of Regulation 10(c) of the SEBI SBEB & SE Regulations, the details of shares allotted are given in "**Annexure -I**".

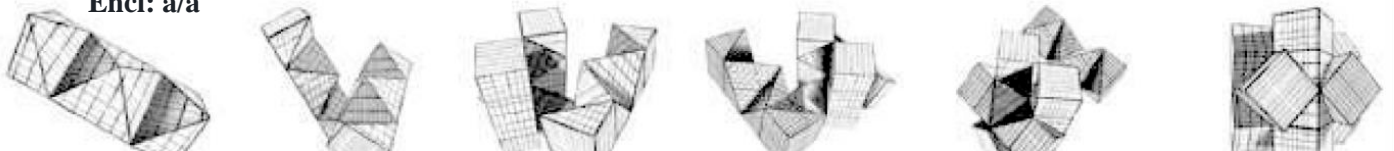
